Parking

Parking is available in the Metropolitan Square parking garage. Please park your car in the garage after set-up.

Registration

All exhibitors must register at the art guild's information booth in Metropolitan Square. Registration and set-up is between 5 pm and 7 pm on Friday evening, June 4th or between 8 am and 10 am on Saturday morning, June 5th.

Categories

The following fine arts media will be accepted: Oil, Acrylic, Watercolor, Pastels, Fiber, Airbrush, Drawing, Oil Pastels, Etching, Scratchboard, Digital Art, Photography, Printmaking, Mixed Media and Three-dimensional Art, including: Sculpture, Jewelry, (hand-crafted only by artist), Wood Carving, Ceramics and Leather.

Only the artists' original work will be accepted.

Spaces

Each exhibitor is responsible for his own display set-up and clean-up at the end of the show. Only one artist or couple per space.

Jury

All applicants must be juried into the fair unless they were members of the Des Plaines Art Guild before April 1, 2010. To be in the fair, members must renew their dues for the 2010-2011 year by May 1, 2010. To jury, please send three (3) slides, color prints, or JPEG files on CD with a self-addressed, stamped envelope by May 15, 2010 to:

Judging

Judging will begin at 11:00 am on Saturday, June 5th. Awards of Excellence and Honorable mention ribbons will be awarded thereafter. Prize money will be awarded on Sunday, June 6th. Purchase Award ribbons will be given at the time the artwork is purchased by a sponsor. Awards will be given at the sole discretion of the judge. Recipients must be present to receive awards.

- No pets allowed
- Admission to the show is free
- Food is available at many restaurants in the area

Prizes

We will present Awards of Excellence of \$50 each and Honorable Mention ribbons with an award of \$25 each.

Fees

- The entry fee is \$80.00 for non-members for a 10' x 10' space and a jury fee of \$5.00
- The entry fee is \$60.00 for DPAG members for a 10' x 10' space.

The entry fee and the jury fee must be separate checks. Make checks payable to: Des Plaines Art Guild. Entry checks will be returned to applicants who are not accepted. The jury fee of \$5.00 is non-refundable. All applicants must include a self-addressed, stamped envelope (please include 88 cents postage) with their applications and checks in order to receive their acceptance/rejection letters, slides and postcards. (CDs will not be returned.)
